Judy gave the budget update. The current balances, are:

Member - \$7,536.20

Property - \$1,369.48

Total - \$86,385.06

She added that last year at this time we were at \$58,000.

Recording Secretary- Debbie Sampson:

Will report on the February meeting minutes next month due to Debbie's absence.

Corresponding Secretary- Laura Henson Brousard:

Laura supplied Karen with notecards and labels to be used as thank you cards for large donations from Sponsors. The Newsletter came out full of wonderful and exciting information. We all thought Laura did a great job and thanked her for her patience with all the articles for this month.

<u>Parliamentarian - Karyn Ferris:</u>

- Currently looking for an outdoor venue for our end of the year luncheon on 6/08/22. After some discussion on different venues, it was decided that we would like to stay with the Blue Water Grill that we already have booked. Karyn to confirm the reservation. - The General Meeting for March will be back at the PV library after a long absence.

- The question of what is the \$20 supply fee used for was asked. Judy Armstrong explained that it is used to reserve the church for bake days as well as supplement supply expenses for bake, creations, and garden shop.
- Lisa asked about the After Event Dinner and if this is something that we should have someone be working on. Karen said this is a dinner that is normally held on a Sunday and spouses are invited to attend. It's a way to celebrate and thank everyone who worked on the Spring Event. Karen suggested a few names to see if they would be willing to organize this dinner.

- Discussed timing for the speaker and how to word it in the program. We will just say Speaker/Luncheon 12:00 p.m.
- We will circulate sign-up sheets, for where we still need help, at the next General Meeting.
- Had a discussion on wine pricing and how we are pricing the etched bee glass. We are thinking of offering the glass for \$15 which would include your wine. If they would like a refill, they can use their glass but pay the \$8 for another glass of wine. Tumblers will also be available for those that do not wish to purchase a glass. We will also sell the glass by itself for \$10.
- Ticket Reservations Donor Snap is ready now and Laura would like to start selling tickets to members as early as next week at the General Meeting. Wording on the Insider will change to tickets are on sale now.
- Laura HB will work Square at the Silent Auction booth so those paying for their items can
 pay immediately instead of paying at Cashier and coming back to the Silent Auction booth.
